AN ORDINANCE CREATING THE SEARCH COMMITTEE FOR THE OUTSTANDING CITIZENS OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, to give due recognition to individuals who have greatly contributed to the development of the municipality and to its people for public service excellence, management excellence, outstanding career and achievements and exemplary contributions, these individuals will be honored and awarded as Outstanding Citizens of the Municipality;

WHEREAS, the Local Government Unit of Nueva Era, in commemoration of the forthcoming centennial celebration of the Municipality will recognize and give awards to these Outstanding Citizens;

WHEREAS, a search committee shall be created to conduct the selection process based on the prescribed guidelines;

NOW THEREFORE, be it ordained in a Regular Session by the Sangguniang Bayan, that:

SECTION 1. TITLE. This shall be known **AN ORDINANCE CREATING THE SEARCH COMMITTEE FOR THE OUTSTANDING CITIZENS OF NUEVA ERA, ILOCOS NORTE.**




