## **MUNICIPAL ORDINANCE NO. 4** Series 2015

AN ORDINANCE PROVIDING INCENTIVE MECHANISM TO INFORMANTS ON THE EXISTENCE/OCCURRENCE OF ILLEGAL ACTIVITIES WITHIN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE AND PROVIDING PENALTIES THEREOF.

WHEREAS, there had been concerned citizens willing to provide information on the existence/occurence of illegal activities that include violation of national and local laws;

WHEREAS, there is a need to provide incentive to informants for better implementation of laws being implemented as it encourages community involvement to sustain peace and order in the municipality;;

WHEREFORE, be it enacted by the Sangguniang Bayan in a regular session assembled, that:

SECTION 1 TITLE. This ordinance shall be known as "AN ORDINANCE PROVIDING INCENTIVE MECHANISM TO INFORMANTS ON THE EXISTENCE/OCCURENCE OF ILLEGAL ACTIVITIES WITHIN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE AND PROVIDING PENALTIES THEREOF.

SECTION 2. COVERAGE. This ordinance shall be applied for violations of ordinances and national laws within the Municipality of Nueva Era, Ilocos Norte.

SECTION 3. DEFINITION OF TERMS. Words defined used in this ordinance:

- 1. INFORMANT- any person or association who provides any information on the existence/occurrence of any illegal activities within the vicinities of Nueva Era.
- 2. INCENTIVE a reward in return of a verified information provided by an informant.
- 3. LAW ENFORCER -all national government agencies such as but not limited to Department of Interior and Local Government (Philippine National Police, Bureau of fire Protection), Department of Environment and Natural Resources, Armed Forces of the Philippines, Department of Agriculture and all other agencies tasked to implement laws and ordinances.
- ROLE OF THEPHILIPPINE NATIONAL POLICE (PNP) the PNP shall validate and verify the information, apprehend the perpetuator in the commission of a crime and file charges against the perpetuator.

5. VIOLATOR – anybody whether natural or juridical entity who commits violation on national laws or ordinances whether resident or non-resident within the Muni cipality of Nueva Era.

SECTION 4. VALIDATION OF INFORMATION. The information shall be given to the Philippine National Police for proper verification and validation.

SECTION 5. INCENTIVE MECHANISM. The grant of monetary reward to any informant with vital information verified and validated by the Philippine National Police in the amount herein provided:

- a) If the penalty imposable of the crime committed is punishable why life imprisonment, the amount of the reward shall be Five thousand pesos (Php 5,000.00);
- b) If the penalty imposable for crime committed is punishable unity prison mayor, the amount of reward shall be Three Thousand Pesos (3,000.00).
- c) If the penalty for violation committed is penalized under local ordinances, the amount of reward shall be One Thousand five Hundred Pesos (1,500.00).

SECTION 6. Funds shall be appropriated in the General Fund to carry out the provisions of this ordinance.

Section 7. EXEMPTIONS. Any information that emanated from the Intelligence Personnel of the Philippine National Police, National Bureau of Investigation and Armed forces of the Philippines and other intelligence agencies shall be excluded in the implementation of this ordinance.

SECTION 8. PENAL PROVISION. Any person or association who intentionally fabricate/make/give false information shall be imposed a fine of one thousand five hundred pesos (Php1,500.00) or proper charges shall be filed in court.

SECTION 9. EFFECTIVITY. This ordinance shall take effect upon approval and after posting in three consecutive weeks at the Municipal Hall of the Municipality.
