MUNICIPAL ORDINANCE NO. 7 S. 2016

AN ORDINANCE ABOLISHING/EXTINGUISHING THE POSITIONS OF MUNICIPAL AGRICULTURAL OFFICER WITH SALARY GRADE 18 AND AGRICULTURAL TECHNOLOGIST WITH SALARY GRADE 10 IN THE OFFICE OF THE AGRICULTURE.

WHEREAS, the positions of Municipal Agricultural Officer and Agricultural Technologist were devolved positions in effect of the RA 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, these positions, Municipal Agricultural Officer with salary grade 18 and Agricultural Technologist with salary grade 10 were absorbed and appropriated funds by the Local Government of Nueva Era in order to carry out the functions of the Agricultural services of the municipality;

WHEREAS, said positions were vacant due to retirement of its personnel; Municipal Agricultural Officer vis-à-vis MR. FELICISIMO MAULIT and Agricultural Technologist vis-à-vis MRS. CRISANTA GAJETE;

WHEREAS, the abolition/extinguishment of said positions is needed to set in order on the Office of the Municipal Agriculture without prejudice to the operation of said office;

WHEREAS, the proposed organizational set up would be the creation of a Municipal Agriculturist with Salary Grade 24 who will head the department;

WHEREFORE, be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte that...

SECTION 1. This ordinance shall be known as **AN ORDINANCE ABOLISHING/EXTINGUISHING THE POSITIONS OF MUNICIPAL AGRICULTURAL OFFICER, SALARY GRADE 18 AND AGRICULTURAL TECHNOLOGIST, SALARY GRADE 10 IN THE OFFICE OF THE AGRICULTURE**

SECTION 2. Unless otherwise specifically provided herein, this ordinance shall take effect immediately upon approval.
