**MUNICIPAL ORDINANCE NO. 08**  
Series 2016

**AN ORDINANCE ADOPTING & RESTRICTING THE USE OF THE MUNICIPAL SEAL & LOGO OF NUEVA ERA, ILOCOS NORTE**

**WHEREAS**, the Municipality of Nueva Era had reached its 100 years of existence (centennial) last January 2016;

**WHEREAS**, the existing municipal seal shall be modified relevant to the founding anniversary of the municipality;

Be it ordained by the Sangguniang Bayan of Nueva Era as follows:

**Section 1. The MUNICIPAL SEAL and LOGO.**

a) The Municipal Seal is described as follows:

Two concentric circles. The two circles are reflected by two black circular lines. The shading between these two circles is dark green where inside of it are the texts "BAYAN NG NUEVA ERA, LALAWIGAN NG (1916) ILOCOS NORTE" printed in white and in capital letters. In the center of the circle is a rectangle whose two upper corners are copular or inverted-arc. Outside the rectangle is no shoring and at its bottom is a deer-head with horn printed in brown.

The rectangle inside the circle capsulized the distinct cultural, agricultural and physical features of Nueva Era.

**Section 2. USE OF MUNICIPAL SEAL & LOGO.**

The Municipal Seal and Logo shall only be used for the official business of the Municipality of Nueva Era, its Municipal Council, Officers or Departments, except upon approval of the Sangguniang Bayan by ordinance or resolution as provided for in this section, no person (natural or juridical) other than the Municipality of Nueva Era, shall reproduce, use, giveaway, sell, or distribute any seal or logo, or facsimile thereof, purporting to be or represented to be the Municipal Seal or Logo of Nueva Era, Ilocos Norte.

**SECTION 3. DEFINITION OF TERMS.** The terms defined as referred to in this ordinance are:

- A. REPRODUCE/REPRODUCTION -refers to the act of making a copy, representation, duplicate or imitation of.
- B. USE- an instance or way of utilizing something.

- C. GIVE AWAY- an act of giving something away.
- D. SELL- to dispose of something to a purchaser for a price.
- E. DISTRIBUTION- passing out or delivering to intended recipients.
- F. SEAL- an embossed emblem, figure, symbol, word or letter used as attestation or evidence of authenticity.
- G. LOGO- a graphic representation or symbol of the Local Government Unit, name or trademark often uniquely designed for ready recognition.
- H. FACSIMILE- an exact copy as a book, painting or manuscript.

**Section 4. ADDITIONAL MUNICIPAL SEALS.**

The Municipality of Nueva Era, through its Sangguniang Bayan, retains the right to create variations of the Municipal Seal and Logo and to adopt and establish other official seals and logos. Such variations may include, but are not limited to, centennial seals, or other seals which mark anniversaries, events, and/or any other municipal occasion the LGU wishes to commemorate.

**Section 5. AMENDMENT OF THE MUNICIPAL SEAL.**

The Municipal Seal maybe amended or revised pursuant to an ordinance of the Sangguniang Bayan.

**Section 6. CUSTODIAN OF THE MUNICIPAL SEAL and other ADOPTED SEALS.**

The Sangguniang Bayan Secretary shall be the official custodian of Municipal Logo.

**Section 7. USE OF MUNICIPAL SEAL or LOGO.**

A recognize employee organization may use the Municipal Seal or Logo, or facsimile thereof, on stationery, and printed materials used in the scope or its representation of municipal employees and on articles of clothing intended for use by municipal employees.

**Section 8. PROMOTIONAL USE OF THE MUNICIPAL SEAL OR LOGO.**

The Municipal Mayor or his/her designee is empowered to authorize the use of the Municipal Seal or Logo on items that are offered for sale by the Municipality of Nueva Era for the purpose of promoting the town. Prior to authorizing such use, the mayor require the criteria used in determining the proposed items and an analysis of the marketability of each item. Only those items bearing the municipal seal or logo that have been authorized by the mayor pursuant to this provision may be offered for sale.

**SECTION 9. ACTS PUNISHABLE.** Under this ordinance

**UNAUTHORIZED:**

- a. reproduction
- b. use
- c. giveaway
- d. sell
- e. distribution
- f. derisive use

of the Seal or Logo are acts punishable under this ordinance.

**Section 10. PENALTY.**

Any violation of the provisions of this ordinance shall be penalized for:

1<sup>st</sup> offense - a fine of One Thousand Pesos (1,000.00) but not more than One Thousand Five Hundred Pesos (Php1,500.00) and/ or imprisonment of not less than two (2)days but not more than five (5) days or both fine and imprisonment at the discretion of the court.



2<sup>nd</sup> offense - a fine of One Thousand Five Hundred Pesos (1,500.00) but not more than Two Thousand Pesos (2,000.00) and/ or imprisonment of not less than five (5)days but not more than ten (10) days or both fine and imprisonment at the discretion of the court.

3rd offense - a fine of Two Thousand Pesos (2,000.00) but not more than Two Thousand Five Hundred Pesos (2,500.00)and/ or an imprisonment of not less than ten (10)days but not more than thirty (30) days or both fine and imprisonment at the discretion of the court.

**Section 9. SEPARABILITY.**

If any provision or section of this ordinance is held to be unconstitutional or invalid by any competent authority, such invalidity shall not affect other provisions or sections thereof.

**Section 10. EFFECTIVITY.**

This ordinance shall take effect upon approval by the Sangguniang Panlalawigan and after its publication in a newspaper of local circulation or posting in conspicuous places at the Municipality of Nueva Era, Ilocos Norte.

**THE HON. VICE GOVERNOR & PRESIDING OFFICER & THE HONORABLE MEMBERS OF THE SANGGUNIANG PANLALAWIGAN:**

**RE: MUNICIPAL ORDINANCE NO. 08 OF NUEVA ERA – AN ORDINANCE ADOPTING & RESTRICTING THE USE OF THE MUNICIPAL SEAL & LOGO OF NUEVA ERA, ILOCOS NORTE.**

**FINDINGS/OBSERVATIONS:**

To adopt a seal and to restrict the use thereof is one of the corporate powers of a public corporation just like the Municipality of Nueva Era pursuant to Sec. 22 (a) (3) of RA 7160. Paragraph (b) of the same section provides:

“Local Government Units may continue using, modify or change their existing corporate seals. Provided, that newly established local government units or those without corporate seals may create their own corporate seals which shall be registered with the Department of Interior and Local Government; Provided, further, That any change of corporate seal shall also be registered as provided herein;”

**RECOMMENDATION/S:**

1. The Municipality of Nueva Era is directed to comply with the registration requirement pursuant to par. (b) Sec. 22 of RA 7160;
2. The committee recommends that Mun. Ordinance No. 08 of Nueva Era be approved and declared VALID.

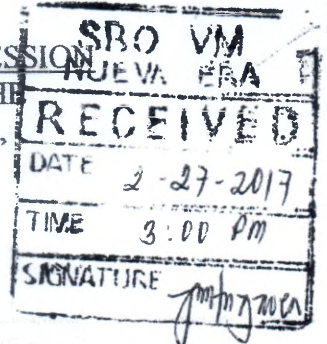
