## MUNICIPAL ORDINANCE NO. 11 Series 2017

### AN ORDINANCE PROVIDING INCENTIVE MECHANISM ON THE BEST PRACTICES FOR SOLID WASTE MANAGEMENT IN THE MUNICIPALITY

WHEREAS, RA 9003 mandates the proper segregation of waste;

WHEREAS, in order to effectively implement laws and rules on the proper segregation of domestic waste, there is a need to provide incentive to complying organizations, establishments, barangays and schools for a healthy environment;

NOW THEREFORE, be it ordained in a session duly assembled that:

SECTION 1. TITLE. This ordinance shall be known as "AN ORDINANCE PROVIDING INCENTIVE MECHANISM ON THE BEST PRACTICES FOR SOLID WASTE MANAGEMENT IN THE MUNICIPALITY."

SECTION 2. COVERAGE. This ordinance shall apply to all barangays, schools and establishments in the municipality that comply with proper segregation and disposal of waste;

SECTION 3. DEFINITION OF TERMS.

- 1. *Waste* refers to the refuse from households as distinguished from industrial waste, agricultural waste, hospital waste, etc., which may be classified as bio-degradable (compostable) or non-biodegradable (non-compostable).
- Recycling refers to the reuse, retrieval of element/matter for any and all purposes necessary to healthful and productive living; the process by which waste materials are transformed into new products in such a manner that the original product may lose their identity.
- 3. **Solid Waste** refers to anything thrown away such as garbage, rubbish, trash, litters, junk and refuse from any source (homes, businesses, farms, industries, or institutions). These are discarded materials with insufficient liquid content to flow.
- 4. Solid Waste Management -- refers to the purposeful, systematic control of the generation, storage, collection, transport, separation, processing, recycling, recovery, and final disposal of solid waste.

- 5. **Sorting at Source** refers to the segregation or separation of waste at the point of generation or at the very place where they are produced into biodegradable and non-biodegradable.
- 6. *Collection* shall refer to the act of removing solid wastes from the source or from a communal storage point.
- 7. **Disposal** shall refer to the discharge, deposit, dumping, spilling, leaking or placing of any solid waste into or in any land.
- 8. **Hazardous Wastes** shall refer to solid waste or combination of solid wastes which because of its quantity, concentration, or physical, chemical or infectious characteristics.
- 9. *Materials Recovery Facility (MRF)* includes a solid waste transfer station or sorting station, drop-off center, a composting facility, and a recycling facility.
- 10. **Segregation** shall refer to a solid waste management practice of separating different materials found in solid waste in order to promote recycling and re-use of resources and to reduce the volume of waste for collection and disposal.

SECTION 4. CRITERIA FOR PROVIDING INCENTIVE. The following are the criteria to be used in the implementation of this ordinance.

- 1. Presence of covered and labeled trash bins.
  - a. LGU shall provide trash bins for Municipal Hall, public market, RHU w/ Lying in clinic, people's center, Balikbayan Hall and other municipal properties.
  - b. Schools and barangays shall provide trash bins to their respective jurisdiction.
  - c. Establishments and Commercial areas shall provide their own trash bins.
- 2. Wastes are properly segregated in trash bins (Nabubulok, di-nabubolok, bote/plastic & hazardous/toxic waste.]
- 3. Waste disposal. No segregation, No collection policy will be applied during the scheduled collection of wastes.
- 4. Presence of Material Recovery Facility. The MRF is a mandatory requirement in all schools and barangays in the municipality.
- 5. Presence of Vermiculture Facility. The Vermiculture Facility is a mandatory requirement in all barangays and schools.
- 6. In the case of barangays, there shall be two compost pit for every household.
- 7. The Barangay Secretary of the Barangay and the School Property Custodian shall keep updated record of recyclable materials collected in their respective barangays or schools.

Waste materials (tires, plastic bottle, cans etc.] that were re-used or converted for display, beautification and other beneficial purposes must be presented during evaluation for merit.

**SECTION 5. MONITORING AND EVALUATION COMMITTEE.** In the implementation of this ordinance, the Monitoring and Evaluation Committee are composed as follows:

The Monitoring and Evaluation Committee shall conduct a monthly surprise visit in the different schools, barangays and establishments for evaluation purposes.

SECTION 6. **INCENTIVE/AWARDS**. Incentive/awards in relation to the implementation of this ordinance shall be given yearly during the town fiesta of the municipality in the following manner:

- a. Cash incentive –shall be given to barangays and schools which will be used in support to solid waste management. Fund shall come from the general fund(Environmental Management fund] of the municipality.
- b. Exemption for garbage collection fee (applicable for establishments].
- c. Replacement of goods for those who will contribute recyclable materials. Barangays concerned will collect recyclable materials from households for sale or storage at the barangay/municipal MRF.
- d. Certificate of Award.

**SECTION 7. SEPARABILITY CLAUSE**. If any part of this ordinance is declared as unconstitutional or unlawful, such declaration shall not affect the other parts or articles hereof that are not declared unlawful or unconstitutional.

**SECTION 8. EFFECTIVITY.** This ordinance shall take effect upon review and approval of the Sangguniang Panlalawigan and after posting in conspicuous places of the municipality.

# THE HONORABLE PRESIDING OFFICER & MEMBERS OF THE SANGGUNIANG PANLALAWIGAN

**RE:** Municipal Ordinance No. 11 Series of 2017 of the Municipality of Nueva Era "AN ORDINANCE PROVIDING INCENTIVE MECHANISM ON THE BEST PRACTICES FOR SOLID WASTE MANAGEMENT IN THE MUNICIPALITY."

## FINDINGS AND OBSERVATIONS:

Republic Act No. 9003, the Ecological Solid Waste Management Act mandates the proper segregation of waste. Moreover, Republic Act Number 7160, otherwise known as the Philippine Local Government Code of 1991 devolved the responsibility for the provision of basic services, such as but not limited to general hygiene and sanitation, beautification and solid waste management to Local Government Units (LGUs).

The aforementioned Municipal Ordinance seeks to provide incentives to complying organizations, establishments, barangays and schools for a healthy environment for the effective implementation of laws and rules on the proper segregation and disposal of wastes.

### **RECOMMENDATIONS:**

The Ordinance, as it has been subjected to a public hearing last March 25-26, 2017, and evidenced by the attached certification, the undersigned committees hereby recommend that Municipal Ordinance No. 11 series 2017, be declared VALID.
