MUNICIPAL ORDINANCE NO.14
 Series of 2018

AN ORDINANCE DECLARING EVERY FIRST WEEK OF SEPTEMBER AS “TINGGUIAN WEEK” IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

Be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that:

SECTION 1. TITLE – This shall be known as “AN ORDINANCE DECLARING EVERY 1ST WEEK OF SEPTEMBER AS “TINGGUIAN WEEK” IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

SECTION 2. DECLARATION OF POLICIES:

- a. It shall be the policy of the local administration to ensure the rights of the indigenous members of the community to participate directly in the development programs and projects and ensure their full participation and involvement in the development process:
- b. This ordinance applies to indigenous peoples (IPs) called TINGGUIANS living in the community who are regarded as indigenous on account of their descent, and whose status is regulated wholly or partially by their own customs or traditions or by special laws or regulations.

SECTION 3. MANDATE – The local administration shall schedule every 1st week of September every year to celebrate and promote the interest and well-being of the indigenous peoples (IPs) of the municipality, with due regard to their beliefs customs and traditions for development.

SECTION 4. PROGRAMS AND ACTIVITIES:

- 1. Mass wedding; with Free Payment of Solemnization fee.
- 2. Blood Letting for every Barangay (for Barangay Blood Bank)
- 3. School Leaders Congress: Symposium
- 4. Tingguian Congress
- 5. Medical Mission;

6. Identification and Membership of persons belonging to the indigenous peoples (IPs) in the Municipality for purpose of establishing qualifications for benefits as maybe provided by law: and
7. Formulate and implement policies, plans, programs and projects for the economic, social and cultural development of the IPs and to monitor the implementation of the same, in consultation with the Commission (NCIP).

SECTION 5. EFFECTIVITY- This ordinance shall take effect upon review and approval by the Sangguniang Panlalwigan.



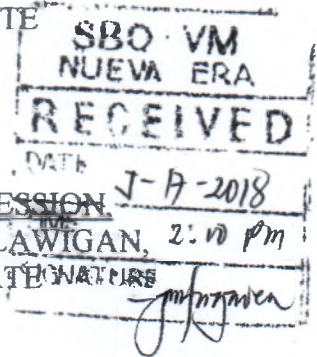


