MUNICIPAL ORDINANCE NO. 15 Series 2018

AN ORDINANCE GRANTING ADDITIONAL INCENTIVE TO CENTENARIANS OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, RA 10868 otherwise known as the Centenarians Act of 2016 provides the granting of additional benefits and privileges to Filipino Centenarians and for other purposes;

WHEREAS, Local Government Units(LGUs] are mandated under the implementing rules and regulations of said act to provide additional incentive in an amount to be determined by the LGU;

NOW THEREFORE, be it ordained in a session duly assembled that:

SECTION 1. TITLE. This ordinance shall be known as "AN ORDINANCE GRANTING ADDITIONAL INCENTIVE TO CENTENARIANS OF NUEVA ERA, ILOCOS NORTE."

SECTION 2. **COVERAGE.** This ordinance shall apply to centenarian Filipino Citizens of Nueva Era, Ilocos Norte;

SECTION 3. DEFINITION OF TERMS.

- 1. Centenarian all Filipino citizens who have reached one hundred years old and above whether residing in the Philippines or abroad.
- 2. Plaque of Recognition- an award given to a living centenarian by the municipality where he or she resides.
- 3. Cash Incentive the amount of cash benefit to be given to the centenarian from the Local Government Unit.

SECTION 4. AWARDS AND INCENTIVE. A centenarian shall receive the following awards and incentives from the Local Government Unit of Nueva Era upon validation or submission of proof of evidence of such centenarian to the Municipal Social Welfare office:

- 1. Cash Incentive the amount of Twenty Thousand Pesos (20,000. 00] will be given to each centenarian of Nueva Era, Ilocos Norte as additional benefit which shall come from the General Fund (Gender and Development fund) of the municipality.
- 2. Plaque of Recognition plaque shall be awarded to centenarian in addition to the cash incentive.

SECTION 5. SEPARABILITY CLAUSE. If any part of this ordinance is declared as unconstitutional or unlawful, such declaration shall not affect the other parts or articles hereof that are not declared unlawful or unconstitutional.

SECTION 6. EFFECTIVITY. This ordinance shall take effect upon review and approval of the Sangguniang Panlalawigan and after posting in conspicuous places of the municipality.
