MUNICIPAL ORDINANCE NO.16
Series of 2018

AN ORDINANCE DECLARING EVERY THIRD WEEK OF OCTOBER EVERY YEAR AS “YOUTH AND CHILDREN’S WEEK” IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

Be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that:

SECTION 1. TITLE – This shall be known as “AN ORDINANCE DECLARING EVERY THIRD WEEK OF OCTOBER EVERY YEAR AS “YOUTH AND CHILDREN’S WEEK” IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

SECTION 2. DECLARATION OF POLICIES:

- a. It shall be the policy of the local administration to promote the general welfare of children and ensure them to participate directly in the development programs and projects and ensure their full participation and involvement in the development process;
- b. It shall also be the policy of the local administration to enable the youth to fulfill their vital role in nation- building and to promote and protect the physical, moral, spiritual, intellectual and social well-being.
- c. The Philippine National Strategic Framework for Plan Development for Children briefly called as “CHILD 21” states the need to be sensitive to the needs of the Child by building a Child-Friendly Society where children are nurtured and allowed to grow and develop in dignity, protected from threats to their well-being and free to express themselves and participate in their development.
- d. This ordinance applies to all pre-schoolers, elementary pupils and junior and senior high school students to enhance their academic knowledge and training skills beneficial in their future development.

SECTION 3.MANDATE – The local administration shall schedule every last week of October every year to celebrate and promote the interest and well-being of the children and youth of the municipality for development. *[Signature]*


