**MUNICIPAL ORDINANCE NO. 19**  
**Series 2018**

**AN ORDINANCE REQUIRING ALL HOUSEHOLDS IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE TO ESTABLISH BACKYARD GARDENING AS ONE OF THE REQUISITES FOR THE ISSUANCE OF CERTIFICATE OF INDIGENCY.**

**WHEREAS**, measures on the goal to eradicate extreme poverty in the country had been initiated to achieve sustainable development of the citizenry;

**WHEREAS**, it has been observed that prices for basic commodities had raised to the alarming level thus affecting the economic condition of every household/family;

**WHEREAS**, backyard gardening in all households/families is considered as the cost-effective, long term solution to food inaccessibility or hunger problem that prevents malnutrition, and to increase the income of the families;

**WHEREAS**, it is a noble action for a family to strive effort and endeavors within their means and capacity under the guidance and supervision of all the barangay entities;

**NOW THEREFORE**, be it ordained in a session duly assembled that:

**SECTION 1. TITLE.** This ordinance shall be known as **“AN ORDINANCE REQUIRING ALL HOUSEHOLDS IN THE MUNICIPALITY OF NUEVA ERA TO ESTABLISH BACKYARD GARDENING AS ONE OF THE REQUISITES FOR THE ISSUANCE OF CERTIFICATE OF INDIGENCY.**

**SECTION 2. COVERAGE.** This ordinance shall apply to all households and families in the Municipality of Nueva Era, Ilocos Norte.

**SECTION 3. DEFINITION OF TERMS.**

Definition of terms used in this ordinance.

1. Backyard gardening – the practice of growing and cultivating vegetable plants in a portion or lot behind a house or structure.
2. Household- a social unit composed of a family living together in the same dwelling.
3. Family- a group of persons united by ties of marriage, blood or adoption constituting a single household and interacting with each other in their respective social positions.
4. Certificate of indigency- document certifying the head of the family on the state of being poor/needy or disadvantaged.
5. Requisite- required or necessary for a purpose.
6. Poverty- the condition where people’s basic needs for food, clothing and shelter are not being met. *Jan*

- 7. Malnutrition-physical condition resulting either from a faulty or inadequate diet.
- 8. Hunger –a condition in which a person, for sustained period is unable to eat sufficient food to meet basic nutritional needs.
- 9. Basic commodities- a reasonably interchangeable good or material bought and sold freely as an article of commerce. Commodities include agricultural products, fuels, and metals and are traded in bulk on a community exchange or spot market.

**SECTION 4. ISSUANCE OF CERTIFICATE OF INDIGENCY.** In the case of barangay, the Barangay Chairman shall issue the Certificate of Indigency upon favorable recommendation of the Barangay Health Worker and Barangay Kagawad assigned for the applicant’s compliance to this ordinance. For the municipality, the Municipal Social Welfare and Development Officer shall issue the Certificate of Indigency upon favorable recommendation of the Monitoring and Evaluation Committee.

**SECTION 5. MONITORING AND EVALUATION COMMITTEE.** In the implementation of this ordinance, the Monitoring and Evaluation Committee are composed as follows:

- Chairman: Municipal Mayor
- Vice Chairman: Municipal Vice Mayor
- MEMBERS: Municipal Health Officer
- Municipal Social Welfare and Development Officer
- Municipal Planning and Development Coordinator
- Municipal Civil Registrar
- Municipal Agricultural Officer
- ALL BARANGAY CHAIRMEN

The Monitoring and Evaluation Committee shall conduct a monthly surprise visit in the different households in all barangays for monitoring and evaluation purposes.

**SECTION 7. SEPARABILITY CLAUSE.** If any part of this ordinance is declared as unconstitutional or unlawful, such declaration shall not affect the other parts or articles hereof that are not declared unlawful or unconstitutional.

**SECTION 8. EFFECTIVITY.** This ordinance shall take effect upon review and approval of the Sangguniang Panlalawigan and after posting in conspicuous places of the municipality.







JOINT COMMITTEE REPORT

MEMBERS OF THE SANGGUNIANG PANLALAWIGAN

RE: MUNICIPAL ORDINANCE NO. 19, SERIES OF 2018 OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE entitled, "AN ORDINANCE REQUIRING ALL HOUSEHOLDS IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE TO ESTABLISH BACKYARD GARDENING AS ONE OF THE REQUISITES FOR THE ISSUANCE OF CERTIFICATE OF INDIGENCY."

FINDINGS AND OBSERVATIONS:

- I. The enactment of Municipal Ordinance No. 19 of the Municipality of Nueva Era, Ilocos Norte is in consonance with the provisions of Section 16 of the Local Government Code of Republic Act 7160, to wit:  
  
*"Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. x x x"*
- II. The rationale of the ordinance is to promote food production through backyard gardening and thereby improve healthy food consumption, food security and self sufficiency.
- III. A public hearing was conducted on October 5, 2018 at the People's Center, Municipality of Nueva Era, Ilocos Norte which was attended by the stakeholders of the municipality.
- IV. A Certification was also submitted as proof that it was posted in the bulletin board at the municipal hall and at the municipal public market on October 23, 2018.

RECOMMENDATION:

The Joint Committee therefore recommends that Municipal Ordinance No. 19, Series of 2018 of the Municipality of Nueva Era, Ilocos Norte be declared **VALID**.






