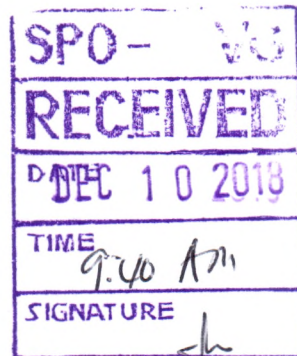

**MUNICIPAL ORDINANCE NO. 21
Series 2018**

AN ORDINANCE CONVERTING THE EXISTING NATIONAL IRRIGATION ADMINISTRATION (NIA) LINK ROAD TO BARANGAY ROAD/TOURISM ROAD AT BARANGAY POBLACION, NUEVA ERA, ILOCOS NORTE.

WHEREAS, the former irrigation road at Barangay Poblacion, Nueva Era, Ilocos Norte is the gateway in going to the municipality’s tourist destination particularly the Nueva Era Eco-Cultural Park;

WHEREAS, there is a need to convert the said road into barangay/tourism road to enhance mobility and convenience of travelers and visiting tourists;

WHEREAS, the conversion of said NIA link road into barangay road/tourism road leads the government authorities in planning for development programs and projects which contribute in the promotion of tourism industry that ultimately uplift the economic well-being of the community;

NOW THEREFORE, be it ordained in a session duly assembled that:

SECTION 1. TITLE. This ordinance shall be known as **“AN ORDINANCE CONVERTING THE EXISTING NATIONAL IRRIGATION ADMINISTRATION (NIA) LINK ROAD TO BARANGAY ROAD/TOURISM ROAD AT BARANGAY POBLACION, NUEVA ERA, ILOCOS NORTE.**

SECTION 2. DEFINITION OF TERMS.

Definition of terms used in this ordinance.

1. Barangay road – road classified within the barangay area of jurisdiction.
2. Tourist destination – place visited by tourist for recreation
3. Convert- refers to a change of existing road classification.
4. Convenience- ease and comfort of travellers
5. Development- physical improvement of a place upgraded for tourist attractions.

SECTION 3. COVERAGE. This shall cover the existing NIA LINK road located at Barangay Poblacion, Nueva Era, Ilocos Norte.

SECTION 4. The Barangay Government of Poblacion, Nueva Era, Ilocos Norte in coordination with the Local Government Unit of Nueva Era, Ilocos Norte shall undertake measures for the improvement and development of said barangay/tourism road.

SECTION 5. SEPARABILITY CLAUSE. If any part of this ordinance is declared as unconstitutional or unlawful, such declaration shall not affect the other parts or articles hereof that are not declared unlawful or unconstitutional.

SECTION 6. EFFECTIVITY. This ordinance shall take effect upon review and approval of the Sangguniang Panlalawigan and after posting in conspicuous places of the municipality.







FINDINGS/OBSERVATIONS:

The purpose of the subject Ordinance is to convert an existing NIA Link Road to Brgy. Road/Tourism Road located at Brgy. Poblacion, Nueva Era, Ilocos Norte.

The word "convert" as defined under the ordinance refers to a change of existing road classification within its territorial jurisdiction.

Posting and public hearing requirements were complied with and with the presumption of regularity in the performance of official functions, the NIA Provincial Office, if it has any interest over the said road other than the reference to the road as NIA Link Road, is considered to have been duly notified.

RECOMMENDATION/S:

The Committee recommends that Municipal Ordinance No. 21 of Nueva Era, Ilocos Norte be approved and declared VALID.
