

# **MUNICIPAL ORDINANCE NO. 2022-46**

### AN ORDINANCE PROVIDING AMNESTY FOR TAXES AND FEES FOR FY 2022 TO THE NUEVA ERA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (NETODA).

WHEREAS, one of the Fundamental Powers of the State is the Police Power to make, ordain, establish all manner of wholesome and reasonable laws for the good and welfare of the people;

WHEREAS, the outbreak of the Corona Virus Disease which was declared as pandemic nationwide had affected the economic condition of the country and the people;

WHEREAS, during the crisis period, financial difficulties of taxpayers in the transportation sector as well as increased public expenditures may occur.

WHEREAS, in response to the economic situation brought about by the COVID 19 pandemic, amnesty for taxes and fees are considered to help relieve the tricycle operators and drivers, who are unable to pay taxes and fees due to the pandemic crisis;

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Nueva Era, Ilocos Norte by virtue of the powers vested in law, in session duly assembled that:

SECTION 1. Title. This ordinance shall be known as "AN ORDINANCE PROVIDING AMNESTY FOR TAXES AND FEES FOR FY 2022 TO THE NUEVA ERA TRICYCLE **OPERATORS AND DRIVERS ASSOCIATION.** 

SECTION 2. Coverage. This ordinance shall apply to the operators and drivers of the Nueva Era Tricycle Operators and Drivers Association. (NETODA).

#### SECTION 3. DEFINITION OF TERMS: As used in this ordinance, terms are defined hereunder:

- a. Tax Amnesty a limited-time opportunity for a specified group of taxpayers to pay a defined amount, in exchange for forgiveness of a tax liability relating to a previous tax period or periods and without fear of criminal prosecution.
- b. Tax- represents money that a government charges to an individual or business when they perform a particular action or complete a specific transaction.
- c. Fee- related to a tax in that it is also a charge paid to the government by individuals or by a business. Fees are mostly imposed to regulate or control various types of activities.

## SECTION 3. TAXES AND FEES APPLICABLE FOR AMNESTY. The following taxes and fees are applicable for amnesty for FY 2022.

a. Annual Tax Fee	: Php400.00
b. Annual Franchise Fee	: Php850.00
c. Filing Fee	: Php250.00
d. Inspection Fee	: Php100.00
e. Legal Research Fee	: Php100.00
f. Parking Fee	: Php200.00
Occupation Fee	: <u>Php200.00</u>
TOTAL	:Php2,100.00

SECTION 5. PENAL PROVISION. Any person violating the provisions of this ordinance shall be penalized by a fine of not less than One Thousand Pesos (1,000.00) but not more than Two Thousand Five Hundred Pesos (2,500.00) in accordance with the Revised Penal Code as the case maybe.

SECTION 6. REPEALING CLAUSE. All Ordinances, resolutions and other issuances inconsistent with the provision of this ordinance are hereby repealed and modified accordingly.

**SECTION 7. SEPARABILITY CLAUSE**. If for any reason any provision of this Ordinance is declared invalid or unconstitutional by appropriate agency or office, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.

# THE HONORABLE PRESIDING OFFICER & MEMBERS OF THE SANGGUNIANG PANLALAWIGAN:

RE: MUNICIPAL ORDINANCE 2022-46 OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE, "AN ORDINANCE PROVIDING AMNESTY FOR TAXES AND FEES FOR FY 2022 TO THE NUEVA ERA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (NETODA)."

#### FINDING/S AND OBSERVATION/S:

Republic Act 7160 otherwise known as the Local Government Code of 1991, Section 16 provides that, the Sanggunian, as the legislative body of the city and municipality, shall enact ordinances to promote the general welfare of the inhabitants within their territorial jurisdiction.

In addition, Section 447 (3) (vi) of the same Code empowers the Local Government Units (LGUs) to regulate the operation of tricycles and to grant franchises within their territorial jurisdiction subject to the guidelines prescribed by the DOTC.

#### **RECOMMENDATION/S:**

In view of the foregoing, the Joint Committee hereby recommends that **MUNICIPAL ORDINANCE NO. 2022-46 OF THE MUNICIPALITY OF NUEVA ERA BE DECLARED VALID.**
