MUNICIPAL ORDINANCE NO. 2022-52

AN ORDINANCE PROVIDING EDUCATIONAL ASSISTANCE AND INCENTIVES TO NUEVA ERA ADAL (ARAPAAP DAGUITI AGTUTUBO KEN LAING) MUNICIPAL SCHOLARS

WHEREAS, Section 1 Article XIV of the 1987 Constitution of the Republic of the Philippines provides that:

"The state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all

WHEREAS, the Local Government of Nueva Era allocate funds to subsidize the need of the students enrolling to grades 11, 12 up to college and its priority goal of projects of alleviating education sector with the aim of at least one professional of every family;

WHEREAS, the grantees of the said project are all learners and are bonafide residents of the 11 barangays of Nueva Era who are officially enrolled in any of the schools, colleges and universities of the country in Luzon area;

WHEREAS, qualified grantees of the said program are entitled to the subsidy in accordance with the budgeting and accounting rules and regulations;

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Nueva Era, Ilocos Norte by virtue of the powers vested by a law, in session duly assembled that:

SECTION 1. TITLE. AN ORDINANCE PROVIDING EDUCATIONAL ASSISTANCE AND INCENTIVES TO NUEVA ERA ADAL (ARAPAAP DAGUITI AGTUTUBO KEN LAING) MUNICIPAL SCHOLARS

SECTION 2. COVERAGE. This ordinance shall apply to the all learners who are enrolled in grades 11, 12, up to college who are bonafide residents of the municipality.

SECTION 3. DEFINITION OF TERMS: As used in this ordinance, terms are defined hereunder:

- A. EDUCATION the process of receiving or giving systematic instruction, especially at a school or university.
- B. LEARNER a person who is learning a subject or skill.
- C. COLLEGE an educational institution or establishment, in particular one providing higher education or specialized professional or in the tertiary level
- D. ADAL Arapaap Daguiti Agtutubo ken Laing
- E. INCENTIVE a thing that motivates or encourages one to do something.





F. SUBSIDY - a sum of money granted by the government or a public body to assist an industry or business, institution or persons to realize a purpose.

SECTION 3. QUALIFICATIONS.

- a. Bonafide resident of the municipality.
- b. Students shall be officially enrolled in any schools, colleges or universities in the
- c. With Good Moral Character as certified by the school.
- d. Enrolled students shall have a passing grade in all subjects at the end of the year/semester.

SECTION 4. EDUCATIONAL ASSISTANCE AND INCENTIVE BREAKDOWN.

The following shall be given the amount of:

a. Senior High School Student : Php 2,500.00 / school year : Php 3,500.00 / semester b. First Year College Student c. Second Year College Student : Php 3,500.00 / semester d. Third Year College Student : Php 3,500.00 / semester e. Fourth Year/Graduating College Student : Php 4,000.00 / semester

f. With Honors Incentives:

CUM LAUDE GRADUATE : Php 5,000.00 MAGNA CUMLAUDE GRADUATE : Php 10,000.00 SUMA CUMLAUDE GRADUATE : Php 15,000.00

SECTION 5. Municipal Scholars shall participate in any community based programs and project of their respective barangays and in the Municipality.

SECTION 6. Funding Requirements. Funds for this project shall come from the Annual Budget of the Municipality under the Educational Assistance Fund.

REPEALING CLAUSE. All Ordinances, resolutions and other issuances SECTION 7. inconsistent with the provision of this ordinance are hereby repealed and modified accordingly.

SECTION 8. SEPARABILITY CLAUSE. If for any reason any provision of this Ordinance is declared invalid or unconstitutional by appropriate agency or office, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 8. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval.

COMMITTEE ON EDUCATION AND CULTURE

THE HONORABLE PRESIDING OFFICER & MEMBERS OF THE SANGGUNIANG PANLALAWIGAN:

RE: MUNICIPAL ORDINANCE NO. 2022-52 OF THE MUNICIPALITY OF NUEVA ERA - "AN ORDINANCE PROVIDING EDUCATIONAL ASSISTANCE AND INCENTIVE TO NUEVA ERA ADAL (ARAPAAP DAGUITI AGTUTUBO KEN LAING) MUNICIPAL SCHOLARS."

FINDINGS & OBSERVATIONS:

The subject ordinance is in conformity with Section 447 (a) (5) (xi) and Article XIV, Section I, of the 1987 Constitution of the Philippines, thus:

'Section 447. Powers, Duties, Functions and Compensation. -

(a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

(5) Approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided for under Section 17 of this Code, and in addition to said services and facilities, shall:

(xi) Establish a scholarship fund for poor but deserving students residing within the municipality in schools located within its jurisdiction;
