## **RESOLUTION NO. 2023 - 134**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. ATTY. ALDRIN R. GARVIDA TO ENTER INTO A MEMORANDUM OF AGREEMENT IN BEHALF OF THE MUNICIPALITY OF NUEVA ERA BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCE- ENVIRONMENTAL MANAGEMENT BUREAU REPRESENTED BY REGIONAL EXECUTIVE DIRECTOR ATTY. CRIZALDY M. BARCELO FOR THE FORMULATION OF THE FOREST LAND USE PLAN OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, Section 3 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, directs the Local Government units to share with the national government the responsibility in the management of natural resources and maintenance of ecological balance within their territorial jurisdiction;

WHEREAS, DENR-DILG-LGU Joint Memorandum Circular No. 98-01 mandates the DENR and LGUs together with other agencies to undertake forest land use as an integral activity of comprehensive land use planning to determine the optimum and balanced use of natural resources to support local, regional and national growth and development;

WHEREAS, the Municipality of Nueva Era, Ilocos Norte is one of the LGUs identified by the Department of Environment and Natural Resources for the formulation of Forest Land Use Plan;

WHEREFORE, after thorough deliberation and in consideration of the terms and conditions, be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that:
