A RESOLUTION EARNESTLY REQUESTING HON. ANGELO MARCOS BARBA, CONGRESSMAN, 2ND DISTRICT OF ILOCOS NORTE TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF DORMITORY FACILITY AT MARIANO MARCOS STATE UNIVERSITY (MMSU) BATAAC CAMPUS INTENDED FOR THE STUDENTS OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE

WHEREAS, Section 16 (General Welfare) of Republic act 7160 otherwise known as the Local Government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain pace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 1 Article XIV of the 1987 Constitution of the Republic of the Philippines provides that:

"The state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, tertiary students needed to look for rent during school days considering the time and distance in traveling from the Municipality of Nueva Era to Bataac City and vice versa;

WHEREAS, most of the students from the Municipality of Nueva Era, Ilocos Norte are enrolled at the Mariano Marcos State University;

WHEREAS, the construction of a dormitory facility at MMSU-Bataac Campus is beneficial to the students of the Municipality enrolled at the university and will lessen their burden for transportation and rental expenses, ensure their safety, and provide convenience in their studies,
