A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE ATTY. ALDRIN R. GARVIDA TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER (MMMH & MC) AS PARTNER IN THE IMPLEMENTATION OF VARIOUS HEALTH SERVICES IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, it is a thrust of the administration to provide an efficient and effective quality of health services to its constituents;

WHEREAS, one of the prerequisites for accreditation of the Rural Health Unit Plus and Lying In Clinic by the Philippine Health Insurance Corporation is to have partner agencies for the implementation of various health services such as TB Dots package, Maternity Care Package and newborn hearing test)

WHEREAS, the RHU Plus and Lying in Clinic is a Basic Emergency Obstetric and Newborn Care (BEmONC) certified health facility that provides obstetric and neonatal care to normal or unaccomplished cases in which identified high risk pregnancies are referred to the tertiary hospital and not allowed to deliver at a BEmONC Facility;

WHEREAS, the RHU Plus and Lying in Clinic set as the Nueva Era Birthing Home, the newborn hearing test cannot be availed due to lack of equipment and trained provider;

WHEREAS, the Mariano Marcos Memorial Hospital and Medical Center, a tertiary facility administered by the Department of Health provides health services with available equipment needed;

WHEREFORE, be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that;

RESOLVED AS IT IS HEREBY RESOLVED TO AUTHORIZE THE LOCAL CHIEF EXECUTIVE ATTY. ALDRIN R. GARVIDA TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER (MMMH & MC) AS PARTNER IN THE IMPLEMENTATION OF VARIOUS HEALTH SERVICES IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE; and
