RESOLUTION NO. 2023-150

A RESOLUTION APPROVING AND ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY PLAN FOR CY 2024 OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, it is the policy of the State to promote peace and order, ensure public safety and further strengthen local government capability aimed towards the effective delivery of the basic services to the citizenry through the establishment of a highly efficient and competent police force. Towards this end, the State shall bolster a system of coordination and cooperation among the citizenry, local chief executives and the integrated law enforcement and public safety agencies;

WHEREAS, Section 16 (General Welfare) of Republic Act 7160 otherwise known as the Local Government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain pace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 116 of RA 7160 authorizes the establishment of Peace and Order Council in every province, sity as municipality with significant role in maintaining peace and order and public safety, in dealing with criminality and insurgency and in curbing in illegal gambling activities;

WHEREAS, after consultation and thorough review of the Peace and Order and Public Safety Plan, this Body hereby:

RESOLVED AS IT IS HEREBY RESOLVED TO APPROVING AND ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY PLAN FOR CY 2024 OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE; and
