A RESOLUTION ENDORSING ONE ILOCOS NORTE ENERGY CORPORATION FOR THE ESTABLISHMENT OF SOLAR FARM PROJECT / RENEWABLE ENERGY IN ALL BARANGAYS OF THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE

WHEREAS, Section 2 of Republic Act No. 9136 otherwise known as the Electric Power Industry Reform Act of 2001 (EPIRA) declared the policy of the State to ensure the quality, reliability, security and affordability of the supply of electric power;

WHEREAS, there had been a proposed Solar Farm Project/Renewable Energy to address the demands of affordable power/energy supply in the populace;

WHEREAS, the members of the Indigenous People in the different barangays had manifest their desire to establish a solar farm project /Renewable Energy in their barangays;

WHEREAS, the Barangay Councils in the different barangays of the municipality had enacted a resolution of no objection on the proposed establishment of the project in their respective barangays;

WHEREAS, said applicant meets the necessary requirements in the establishment of the project.

WHEREAS, global warming and climate change affect the supply and demand of power energy in the community and the said project will benefit the consuming public as it will lessen their burden of power/electricity consumption cost while this will increase the income of the municipality;
