RESOLUTION NO. 2023-161

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO LEASE AGREEMENT WITH ANY INVESTOR, PARTNERSHIP, CORPORATION OR INDIVIDUAL FOR LOTS OWNED BY THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE FOR THE ESTABLISHMENT OF RENEWABLE ENERGY OR INDUSTRY IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE

WHEREAS, Section 2 of Republic Act No. 9136 otherwise known as the Electric Power Industry Reform Act of 2001 (EPIRA) declared the policy of the State to ensure the quality, reliability, security and affordability of the supply of electric power;

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code provides that:

*Every local government unit shall exercise the powers expressly granted those necessarily implied therefrom, as well as the powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order and preserve the comfort and convenience of their inhabitants."

WHEREAS, the establishment of a renewable energy or industry in the Municipality will benefit the community as it will lessen the electricity cost of the consuming public while increases the income of the municipality thru taxes being collected from any investor;

WHEREFORE, be it resolved by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that:

RESOLVED, AS IT IS HEREBY RESOLVED TO AUTHORIZE THE LOCAL CHIEF EXECUTIVE TO ENTER INTO LEASE AGREEMENT WITH ANY INVESTOR, PARTNERSHIP. CORPORATION OR INDIVIDUAL FOR LOTS OWNED BY THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE FOR THE ESTABLISHMENT OF RENEWABLE ENERGY OR INDUSTRY IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE; and
