A RESOLUTION EARNESTLY REQUESTING DIR. PAULA PAZ M. SYDIONGCO, MD, MPH, MBA, CESO IV, REGIONAL DIRECTOR, DEPARTMENT OF HEALTH, REGION I TO PROVIDE TWO (2) UNITS HEMODIALYSIS MACHINE FOR USE IN THE MUNICIPALITY OF NUEVA ERA, ILOCOS NORTE.

WHEREAS, the Municipality of Nueva Era, Ilocos Norte is located in the eastern part of the Province of Ilocos Norte bounded by the Provinces of Abra, Ilocos Sur and Apayao;

WHEREAS, the Rural Health Unit Plus and Lying in Clinic of Nueva Era is catering health services at 24/7 within the municipality and the nearby towns of Pinili, Banna and Badoc, Ilocos Norte;

WHEREAS, it is a thrust of the administration to provide an efficient and effective quality of health services to its constituents but the facility lacks the needed equipment;

WHEREAS, a hemodialysis machine is one of the priority needs in the municipality considering its geographical location to accommodate the needy patients in the locality;

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code provides that:

"Every local government unit shall exercise the powers expressly granted those necessarily implied therefrom, as well as the powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government shall ensure and support among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order and preserve the comfort and convenience of their inhabitants."

WHEREFORE, be it enacted by the Sangguniang Bayan of Nueva Era, Ilocos Norte, that;
