

COMMITTEE REPORT (Committee on Appropriations)

THE HONORABLE PRESIDING OFFICER
AND SB MEMBERS

Subject: Barangay Appropriation Ordinance No. 03, Series of 2022 dated November 15, 2022 covering the Annual Budget FY 2023 of Barangay #4 Cabittauran Nueva Era, Ilocos Norte involving a Total of Php. 2,746,154.00.

Findings and Observations:

The Committee hereby adopts the recommendation of the Local Finance Committee, that:

1. The items out of the Local Disaster Risk Reduction Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction Management Act of 2010 and its IRR, and the DBM-NDRRMC-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re *Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund*.
2. The personal services shall be made in accordance with Local Budget Circular No. 098 dated October 14, 2011 shall not exceed Fifty-five percent (55%).
3. The grant of Year-End Bonus & Cash Gift shall be made in accordance with Budget Circular No. 2016-4 dated April 28, 2016.
4. The payment National PhilHealth Insurance premium shall be in accordance with provisions of PhilHealth Circular No. 2020-4 dated February 27, 2020.
5. The projects under the 20% OF THE Annual Internal Revenue Allotment for development projects **Php. 443,740.00** shall be subject to the provisions of DBM-DOF-DILG-Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020.
6. The procurement to be undertaken shall strictly be subject to the provisions of R.A. 9184, (the Government Procurement Reform Act) and it's IRR.

Recommendations:

The committee hereby recommends that Appropriation No. 01 be declared **VALID**.
